REMADE VENDOR/SUPPLIER TERMS AND CONDITIONS ("T's and C's")

1. Vendor/Supplier Information

1.1 The onus is on the Vendor/Supplier to notify Remade of any changes to information as contemplated in section 1 of this Application.

2. Banking details

2.1 The Vendor/Supplier shall notify Remade in writing in the event of changed banking details.

2.2 The Vendor/Supplier consents that Remade may request any confirmation they deem fit to verify the correctness of the bank details.

2.3 Remade will not be responsible/liable for any loss or damage suffered by a Vendor/Supplier due to incorrect bank details supplied. The Vendor/Supplier indemnifies Remade in this regard.

2.4 All payments to the Vendor/Supplier will be made timeously as agreed between the Vendor/Supplier and Remade. Remade will notify the Vendor/Supplier in writing if, due to unforeseen circumstances, payments can not be processed as agreed between the Vendor/Supplier and Remade.

2.5 Unless otherwise agreed in writing, Remade shall be entitled to withhold payment to a Vendor/Supplier, if the Vendor/Supplier/Supplier has an overdue balance due to Remade.

2.6 A certificate from the bankers of Remade ("Final Audit Report") confirming a payment, will be the final and accepted proof of payment.

2.7 Remade shall not be held liable for any damages or losses suffered by the Vendor/Supplier/Supplier due to the transfer time of funds between Remade's bank and the bank of the Vendor/Supplier.

3. Black Economic Empowerment

3.1 The Vendor/Supplier shall notify Remade in writing in the event of a change to its BEE status.

3.2 The Vendor/Supplier shall provide Remade with an updated and valid BEE verification certificate on an annual basis.

4. Value Added Tax (Only applicable for VAT registered Vendor/Suppliers)

4.1 The Vendor/Supplier grants permission to Remade to issue tax invoices, credit notes and debit notes for supplies made by the Vendor/Supplier to Remade.

4.2 The Vendor/Supplier and Remade are registered Vendor/Suppliers in terms of the Value-Added Tax Act, No. 89 of 1991.

4.3 Remade and the Vendor/Supplier acknowledge that sections 20(2) and 21(4) of the Value-Added Tax Act, No. 89 of 1991 make provision for Remade to issue tax invoices, credit notes and debit notes for supplies made by the Vendor/Supplier to Remade.

4.4 Remade and the Vendor/Supplier further acknowledge that the Commissioner for the South African Revenue Service has issued guidelines regarding the requirements that must be satisfied before Remade can issue tax invoices, credit notes and debit notes for supplies made by the Vendor/Supplier to Remade and acknowledge that the supplies concerned comply with BGR (VAT) No. 15 (Issue 2).

4.5 Remade undertakes to:

4.5.1 issue recipient-created tax invoices, credit notes and debit notes in compliance with the provisions of sections 20(4), (5), 21(1) or 21(3) of the Value-Added Tax Act, No. 89 of 1991, respectively.

4.5.2 provide to the Vendor/Supplier a recipient-created tax invoice, credit note and debit note within the periods stipulated in the Value-Added Tax Act; and

4.5.3 retain a copy of the recipient-created tax invoice, credit note and debit note.

4.6 The Vendor/Supplier hereby undertakes not to issue any tax invoice, credit note and debit note for taxable supplies falling within this agreement and further acknowledges that in the event that a tax invoice, credit note and debit note is issued by the Vendor/Supplier, it shall be deemed not to be a tax invoice, credit note and debit note for the purposes of the Value-Added Tax Act, No. 89 of 1991.

4.7 Remade and the Vendor/Supplier undertake to notify each other if either party:

4.7.1 ceases to be a Vendor/Supplier;

4.7.2 changes its VAT registration number;

4.7.3 supplies its enterprise, or part of its enterprise; or

4.7.4 materially changes its enterprise that could affect this agreement.

5. General

5.1 The Vendor/Supplier irrevocably declares and confirm that he/she/they are the lawful owners of the supplies made to Remade.

5.2 The Vendor/Supplier irrevocably declares and confirm that the goods supplied is a taxable supply.

5.3 Remade may deduct a contamination factor on supplies made.
